

2005 Cohort Default Rates

On September 16, 2008, the U.S. Department of Education released the 2006 default rates for each postsecondary institution. The 2006 rates are the latest available, and they represent the number of borrowers who defaulted on their federally guaranteed student loans within 12 to 24 months after leaving postsecondary education. More precisely, the Fiscal Year 2006 default rate is a snapshot in time of borrowers who began repaying their loans between October 1, 2005 and September 30, 2006 and who defaulted before Sept. 30, 2007.

National Cohort Default Rate

The national federal student loan cohort default rate for 2006 is 5.2 percent, as compared to 4.6 percent for Fiscal Year 2005 and 5.1 percent for Fiscal Year 2004.

Minnesota Cohort Default Rate

Borrowers who attended Minnesota institutions had a cohort default rate of 2.9 percent for 2006, compared to a rate of 3.0 percent for 2005 and 3.2 percent for 2004.

Default Rates for Institutions in Minnesota

The U.S. Departments of Education's report on 2006 default rates included 101 institutions in Minnesota. Default rates changed by more than half of one percent or stayed the same as follows:

- 29 Minnesota institutions had 2006 default rates that were higher than their default rates in 2005.
- 29 Minnesota institutions had 2006 default rates that were lower than their default rates in 2005.
- 43 Minnesota institutions had 2006 default rates that were the same as their rates in 2005.

Cohort default rates for each institution for 2006 are shown in Figures 1 through 5. There were 11 Minnesota institutions that had zero default rates – no students defaulted.

Categories of Default Rates and Sanctions

If an institution has cohort default rates of 25 percent or more for the three most recent years, students attending the institution will not be eligible for Federal Stafford Loans and Federal Pell Grants for the remainder of that fiscal year and the following two fiscal years. Minnesota had no institutions with default rates that were subject of sanctions by the U.S. Department of Education.


If an institution has a cohort default rate of 40 percent or more for one year, students attending the institution will not be eligible for Federal Stafford Loans for the remainder of that fiscal year and the following two fiscal years.




Minnesota Public Two-Year Colleges 2006 Default Rates




Minnesota Public Four-Year Universities 2006 Default Rates




Minnesota For-Profit Institutions 2006 Cohort Default Rates
