


#### Minnesota State Grant Statistics: Recipients Applying as Dependent Students Registering for Less Than 30 Credits, Fiscal Year 1999








#### Minnesota State Grant Statistics: Recipients Applying as Dependent Students Registering for at Least 30 Credits, Fiscal Year 1999








#### Minnesota State Grant Statistics: Married Students with No Other Dependents Applying as Independent Students, Fiscal Year 1999


