
Minnesota State Grant Statistics, Fiscal Year 2000




Minnesota State Grant Statistics: Recipients Applying as Dependent Students Registering for Less Than 30 Credits, Fiscal Year 2000








Minnesota State Grant Statistics: Recipients Applying as Dependent Students Registering for at Least 30 Credits, Fiscal Year 2000



Minnesota State Grant Statistics: Married Students with Dependents Applying as Independent Students Registering for at Least 30 Credits, Fiscal Year 2000












Minnesota State Grant Statistics: Unmarried Students with Dependents Applying as Independent Students, Fiscal Year 2000



Minnesota State Grant Statistics: Unmarried Students with Dependents Applying as Independent Students Registering for at Least 30 Credits, Fiscal Year 2000



Minnesota State Grant Statistics: Married Students with No Other Dependents Applying as Independent Students Registering for at Least 30 Credits, Fiscal Year 2000








