Executive Summary

The Office of Higher Education is required by the Minnesota Legislature to publish the Sexual Assault Data Report, which includes information regarding the outcomes of sexual assault incidents reported to postsecondary institutions. The Minnesota Legislature ([Minn. Stat. 135A.15¹](#)) mandated this report beginning in Fiscal Year 2016 (data for calendar year 2015) which requires eligible postsecondary institutions to report sexual assault incidents and the outcomes of institutional investigations, if applicable. Key Takeaways

- Since calendar year 2016, postsecondary institutions have received a cumulative 2,041 reports of sexual assault incidents. The number of reports of sexual assault incidents have steadily increased in the past four years, with the exception of 2020 (2019 calendar year) and 2021 (2020 calendar year).
- Over the most recent six years, about two in five incidents (40.6%) of sexual assault reported to the postsecondary institution were investigated. In 2021 (calendar year 2020), institutions reported that an estimated one in four incidents reported were investigated (28.4%). Institutions cite changes in Title IX reporting regulations and remote learning environments in which victims are less likely to encounter respondents as drivers of the change.
- About 1 in 6 (16.9%) cumulative incidents of sexual assault reported to the postsecondary institution were also reported to law enforcement, to the institutions' knowledge, as compared to 1 in 10 (10.9%) in 2021 (calendar year 2020).
- The number one reason cited by institutions for an institutional investigation not being opened is that the complainant chose not to participate in the investigatory process, as was the case for 879 out of 2,005 incidents from 2017-2021, or 43.8% of incidents. Complainants sometimes elect this route to receive supportive measures without undergoing a Title IX investigation. Note that the outcome Victim Did Not Participate Pre-Disciplinary Process was added to the report in 2017, and therefore 2016 data is unavailable for this calculation.
- Given the pandemic and move to remote learning in March 2020, institutions cited changes in the prevalence of sexual assaults, Title IX processes, and student behavior as part of the reporting and investigation processes. In addition, changes in Title IX federal regulations, including the move to campus hearing boards and the use of administrative law judges, during summer 2020 increased the burden on campuses in responding effectively to Title IX issues.

Data Privacy

The Minnesota Office of Higher Education (OHE) adheres to current federal and state data privacy laws and best practices to protect the privacy of individual students. [Minn. Stat. § 135A.15, Subd. 6²](#) requires that reports and data are prepared and published as summary data, as defined in [Minn. Stat. § 13.02, Subd. 19³](#) and are consistent with federal and state laws governing access to educational data and student privacy.

OHE's policy for complying with federal and state data privacy laws is to suppress student data in cells containing fewer than 10 students. In this report, cells with counts under 10 are suppressed, including zero values where the number of incidents reported or the number of incidents investigated is greater than zero from which information could be inferred.

Title IX during the Pandemic

Given the pandemic and move to remote learning in March 2020, institutions cited changes that impacted sexual assault data used for this report. The Office of Higher Education surveyed institutions as to the changes in sexual assault prevention, reporting and investigation processes, and/or data reported as a result of the pandemic, as well as changes occurring in 2020 that were not related to the pandemic, but rather resulted from federal or institutional policy and practices.

Pandemic Changes

Institutions reported four areas of change as a direct result of the pandemic, as follows:

- Institutions moved to online processes for reporting, investigating, and communicating with victims.

The move to online learning was accompanied by a move to online processes and supports in response to sexual assaults on campus. Many of the online or virtual processes required colleges to still have in-person human supports such as counseling and initial contacts for students. Distributing information about sexual assault prevention and reporting was also more difficult as colleges had fewer options for campus or community outreach as students were not on campus. Among colleges reporting pandemic impacts, responses were split as to whether the move online made reporting and investigation easier or harder for students. There was also recognition that sexual assault stigma still existed even if students reported online and investigations were conducted virtually.

- The prevalence of sexual assault decreased due to fewer opportunities

Institutions noted that the decline in sexual assault reported were the result of fewer students on campus after the move to remote learning, fewer social events, and restricted access policies for on-campus or campus-owned housing to prevent infection spread.

- Decline in the willingness of victims to move forward in the investigation process

Campuses noted a decline in the willingness of victims to pursue the investigation process. The decline in willingness was attributed to remote learning in which victims were less likely to encounter respondents. Also, the change in Title IX regulations mid-year created uncertainty among students and an increased feeling that the Title IX process was burdensome for victims.

Non-Pandemic Changes

In addition, institutions reported two areas of change that occurred in 2020 which were not pandemic-related, as follows:

- Problems implementing the changes in federal Title IX regulations

Campuses noted two changes to federal Title IX regulations that have been more concerning or difficult to implement. The first of these changes is the move to Chapter 14 hearings. The second change was the requirement that students file formal complaints even before proceeding with informal resolution processes.

- Change in Minnesota State Processes

Due to the changes with the title IX regulations, Minnesota State has shifted to use the Chapter 14 hearing before an administrative law judge, instead of campus hearing boards. This change has resulted in many students to not want to go through with the Chapter 14 hearing. Instead these students may have opted to go through informal resolution.

As shown in Table 2, postsecondary institutions have received a cumulative 2,299 reports of sexual assault incidents since 2016. The number of reports of sexual assault incidents have steadily increased in the past four years, with the exception of 2020 (2019 calendar year) and 2021 (2020 calendar year).

Over the most recent six years, 934 of the 2,299 incidents (40.6%) of sexual assault reported to the postsecondary institution were investigated. In 2021 (calendar year 2020), institutions reported that 71 of the 258 incidents reported were investigated (28.4%). Institutions cite changes in Title IX reporting regulations and remote learning environments in which victims are less likely to encounter respondents as drivers of the change.

As shown in Table 2, 389 of the 2,299 (16.9%) cumulative incidents of sexual assault reported to the postsecondary institution were also reported to law enforcement, to the institutions' knowledge, as compared to 1 in 10 (10.9%) in 2021 (calendar year 2020).

As shown in Table 3, the number one reason cited by institutions for an institutional investigation not being opened is that the complainant chose not to participate in the disciplinary process, as was the case for 879 out of 2,005 incidents from 2017-2021, or 43.8% of incidents. Complainants sometimes elect this route to receive supportive measures without undergoing a Title IX investigation. Note that the outcome *Victim Did Not Participate Pre-Disciplinary Process* was added to the report in 2017, and therefore 2016 data is unavailable.
